The meeting was a hybrid meeting located in the Fire Department training room located at 411 E. Main St. as well as concurrently held via Zoom.

- 1. Call to order Manley called the meeting to order at 6:00 p.m.
- 2. Roll call and verification of quorum All members were present.
- 3. Certification of compliance with open meeting law
- **4. Public Comment** Swadley introduced Mark Pressprich and indicated that Mark was interested in investing in our community.
- **5. Communications** Springman updated everyone regarding the Friends of the Yahara River and the Peter Bruno honor flight. G. Becker discussed the downtown Tax Incremental Financing projects. K. Becker indicated the Innovation Center Stoughton is hosting the Children's Business Expo.
