Motion by Riley, second by Doom to language changes that include changing domesticated pets to dogs and municipal owned property to City owned property. Motion carried 5-0.

Motion by Riley, second by Doom to recommend that council approve the ordinance amendment. Motion carried 5-0.

Discussion and possible action regarding Amending Chapter 70-176 of the City of Stoughton Municipal Code; by creating subsection (81) relating to designating Yellow Curb Paintings as official No Parking Zones

Motion by Doom, second by Ligocki to recommend that council approve the ordinance amendment. Motion carried 5-0.

Discussion and possible action regarding Amending Chapter 70-221 of the City of Stoughton Municipal Code; by adding subsection 144 relating to stopping restrictions on Glacier Moraine Drive at Williams Drive

Motion by Ligocki, second by Doom to recommend that council approval the ordinance amendment. Motion 5-0.
