Call to Order

Clerk Licht called the meeting to order at 6:05 p.m.

Election of Chair and Vice Chair

Doom nominated Jenson to serve as Chair. There were no other nominations. Jenson was elected chair on a vote of 5-0. Doom nominated Ligocki as vice-chair. There were no other nominations. Ligocki was elected vice-chair of the committee on a vote of 5-0.

Approval of the May 27, 2020 Public Safety Minutes

Motion by Doom, second by Ligocki to approve the minutes. Motion carried 5-0.0

Discussion and possible action regarding leash law review

Jenson said that he would like to see that a leash be required on public property. Chief said that he would work on getting the change in the ordinance. This item will be back before the committee at its next meeting.

Discussion and possible action regarding an application for a Class "A" Fermented Malt Beverage License and "Class A" Intoxicating Liquor License for KPW Hospitality, LLC d/b/a Tru by Hilton, located at 2500 Jackson St., Paul Harms, Agent

Clerk Licht explained that this was a Class A license that would allow hotel guests to purchase beer and wine in an original container in a market area for consumption in their rooms or common areas of the hotel. Motion by Riley, second by Ligocki to recommend that council approves the license. Motion carried 5-0.

Discussion and possible action regarding annual Outdoor Consumption Permit Renewals for the period of July 1, 2020-June 20, 2021

Clerk Licht explained that she did not charge the typical \$25/business day late fee due to City Hall being closed and not have adequate drop box options. The committee gave unanimous to waive the late fees for the applications.

Chief Leck asked that the 50 point violations for Viking Lanes and Shakers will be applied to the 2020-2021 year given Shakers suspension and ongoing litigation with Viking Lanes. Motion by Riley, second by Ligocki to recommend that council approve the license renewals. Motion carried 5-0.

Discussion and possible action regarding annual Outdoor Consumption Permit Renewals for the period of July 1, 2020-June 20, 2021

Motion by Doom, second by Ligocki to recommend that council approve the Outdoor Consumption Permit renewals. Motion carried 5-0.

Discussion and possible action regarding approving an operator license for Carly Hougan

Motion by Doom, second by Ligocki to recommend that council deny the license. Motion carried 5-0.

Discussion and possible action regarding approving an operator license for Jacob Medinger

Motion by Ligocki, second by Doom to recommend that council deny the license. Motion carried 5-0.

Discussion and possible action regarding Hoel & Korgen Traffic complaint

Chief Leck recommended that we do not put a 4 way stop at that intersection as it would cause more traffic issues. Chief will check will Public Works to see if they have any children at play signs to put up in the area and chief will contact the citizen that made the complaint.

Discussion and possible action regarding idling cars complaint

Chief Leck state that the downtown area has frequent stops and deliveries and any ordinance would require many exceptions to accommodate a business district. Also, the infrequent of violations would make it very difficult to enforce. The committee took no action on this item.
