WHEREAS, the proposed property tax mill rate is \$6.5137 which is a decrease of \$0.4964 or 7.08% from the prior year; and,

WHEREAS, the proposed budget for Storm Water Equivalent Runoff Units (ERUs) is \$84.12 per year which is an increase of \$3.06 or 3.9%; and,

WHEREAS, the proposed budget for refuse collection fees is \$207.36 which is an increase of \$7.09 or 3.5%;

NOW THEREFORE BE IT RESOLVED, by the Common Council of the City of Stoughton that the 2024 budget appropriations in the sums and for purposes herein set forth be the same are hereby approved; and,
