Landmarks Commission Meeting Minutes Thursday, November 10, 2016 – 7:00 pm City Hall, Hall of Fame Room, Lower Level, 381 E. Main Street, Stoughton, WI.

1. Call to order. Veregin called the meeting to order at 7:00 pm.

2. Consider approval of the Landmarks Commission meeting minutes of October 13, 2016. Motion by <u>Hedstrom</u> to approve the minutes as presented, 2^{nd} by <u>Tass-Johnson</u>. Motion carried 6-0.

3. Request by Mike Daniels for a Certificate of Appropriateness to install a sign on the Erickson Building at 194 W. Main Street.

Veregin introduced the request and noted there is new information provided by the applicant including signage on the window.

Mike Daniels explained the corporate requirements set by Farmers Insurance and that a smaller wall sign is possible. The color of the exterior wall sign will dictate the color of the window sign.

There was a lengthy discussion about having a projecting sign instead of the wall sign and Mike Daniels is fine with that change.

There was consensus that the projecting sign would be made of aluminum and in color as proposed with the location being on the front wall at the corner of the building. There will be a minimum of 9 feet of clearance from the bottom of the sign to grade and the sign shall be attached with a metal wrought iron frame into mortar joints only. The window signage would be mostly white in color as proposed.

Hedstrom left at 7:30 pm

Mike Daniels will provide an update to Zoning Administrator Stacey via email and Stacey will disburse to the Commission for approval.

Motion by <u>Mabie</u> to approve the Certificate of Appropriateness contingent on the projecting sign being made of aluminum and in color as proposed. The projecting sign shall be installed with a metal frame on the front wall at the corner of the building and attached into mortar joints. The size of the sign shall be consistent with the recently approved projecting sign for Back to the Bean as discussed. The store front window signage shall be white in color as proposed, 2^{nd} by <u>Tass-Johnson</u>. Motion carried 5-0.

4. Discuss the Association for Preservation Technology International Annual Conference.

Mar-Pohl is absent so this will be on the agenda next month.

5. Discuss 1892 High School Coalition group sessions.

Veregin stated there has been one focus group session thus far. Veregin played a preliminary video made by Eric Francksen to provide information toward finding a use for the 1892 High School. The plan is to add 3D modeling provided by Stephen Mar-Pohl.

6. Discuss Preservation Conference, Oct 21 – 22 at Wisconsin Dells.

Tass-Johnson attended and provided feedback. Veregin also attended the conference while Stephen Mar-Pohl presented at the conference. The conference will be in LaCrosse next year.
