Landmarks Commission Meeting Minutes Thursday, May 11, 2017 – 7:00 pm City Hall, Hall of Fame Room, Lower Level, 381 E. Main Street, Stoughton, WI.

- 1. Call to order. Veregin called the meeting to order at 7:06 pm.
- 2. Elect Chair.
- 3. Elect Vice-Chair.
- 4. Elect Secretary.

Motion by **Swadley** to continue with current slate of officers, second by Mar-Pol. Motion carried 6 - 0. (Veregin, Chair; Hedstrom, Vice-Chair; Pigarelli, Secretary)

- 5. Consider approval of the Landmarks Commission meeting minutes of April 13, 2017. Motion by <u>Hedstrom</u> to approve the minutes as presented, 2^{nd} by <u>Mar-Pohl</u>. Motion carried 6 -0.
- 6. Request by Phillip Knutson for approval of a Certificate of Appropriateness and for Design Review to install new awnings at 110 E. Main Street.

Motion by <u>Cook</u> to approve the Certificate of Appropriateness as presented, 2^{nd} by <u>Mar-Pohl</u>. Motion carried 6-0.

Motion by <u>Mar-Pohl</u> to recommend the Planning Commission approve the Design of the awnings as presented, 2^{nd} by **Hedstrom.** Motion carried 6-0.

7. Review local landmark eligibility for the Highway Trailer Building (HTB).

The commission reviewed the eligibility of the building against the criteria set forth in the Landmarks Ordinance. A report was recently completed for the RDA which evaluated the historic significance of the property. The commission used the research compiled in this report. The report evaluated the HTB complex as a whole and /or the foundry and blacksmith shop by themselves. Our opinion is that the HTB complex is not eligible as a whole, but the HTB meets four of the six criteria for local landmark eligibility. The individual building has significance for architectural, social, cultural, and economic history. Mar-Pohl to reach out to the preparer of the report and ask if she would be willing to reorganize the information into a local landmark nomination. Designation as a local landmark would need to follow the process outlined in the Landmarks Ordinance.

The next step: send the National Register Questionnaire to the State Historic Preservation Office for evaluation of eligibility for the National Register of Historic Places. Swadley asked Veregin to attend the next City Council meeting and update the Council to help keep them informed.

Motion by <u>Hedstrom</u> to recommend Local Landmark nomination, 2^{nd} by <u>Mar-Pohl</u>. Motion carried 6-0.

Mar-Pohl will contact Gail Kline (author of HTB Complex report/questionnaire) for assistance with the local landmark nomination form.

8. Discuss local landmark mini-grants.

City staff sent out the letters the last week in April and have not yet heard from prospective applicants.

9. Discuss preservation award nominations.

No update – deferred until next meeting.

10. Discussion proposed changes to city ordinances regarding demolition of a building in a historic district.

Veregin plans to meet with Attorney Dregne in May to outline what is planned to be amended. Veregin will bring the proposed amendments to the Commission for review and comment. Report, outline and action plan to follow at future Landmarks meeting.

11. Discuss status of the 1892 High School.

Survey is closed, focus groups have finished and analysis is underway.

Veregin to meet w/ Stoughton School District Superintendent and school board member-Steve Jackson, next week regarding proposed UW-Madison senior-level engineering course project to evaluate potential re-use options for the 1892 High School.

Swadley reports that the Stoughton Community Foundation to act as the 501 (c) (3) for the 1892 High School Coalition during fundraising campaign. The School Board Facilities Committee will meet in May and Swadley asked Veregin to come to the meeting and update the Committee regarding the 1892 High School Coalition's progress.

12. Discuss status of the Milfab/Highway Trailer/Power Plant development.

Tabled until next meeting.

13. Discuss CLG grant application.

Nothing in the works at this time, deferred to June Landmarks meeting.
