Public Works Committee Thursday, February 17th, 2022 (Virtual Meeting)

Call to Order: Majewski called the meeting to order at 6:02 PM

1) Communications:

- Hebert stated we've been fortunate enough to avoid a lot of snow this winter however, it has left us with an excessive amount of salt leftovers. He is working to utilize neighbors for storage space.
- 2) <u>Approve January 20th, 2022 Meeting Minutes:</u> Motion by Reeves seconded by Hundt to approve the minutes. Motion carried 6-0.

Old Business:

3) Review and Approve the Hwy 51 Roundabout Landscaping Design and Layout:

Hebert presented the Saiki finalized plans and where each concept will be placed at each location throughout the City. Discussion was had about when current roundabouts would be rehabbed and *Hebert* stated that would start this spring.

Motion by Reeves, seconded by Venegas to approve. Motion carried 6-0

New Business:

4) Review and Approve the DOT SMFA Agreement Regarding Segment 2A on Hwy 51 (Main ST) from Fifth St to Spring Rd:

Scheel presented cost allocations from the DOT as they are preparing plans for the 2025 reconstruction and showed how portions of the project are allocated to the City. The DOT standard lighting would be a 50/50 cost split but if there were upgrades made, it would be at the City's cost. Discussion was had about keeping all light the same vs. changing from sides of town; east to west.

Motion by Reeves, seconded by Venegas to recommend this go to Council for approval. Motion carried 6-0

5) <u>Update on the 2022 Reconstruction and Pulverization Projects – Public Meeting to Follow</u> at 7:00pm at the Fire Station:

Hebert presented a map of specific roads that are part of the project however, most are not necessarily pulverization projects but rather reconstruction as in grading, curb & gutter and storm sewer issues. The only pulverization project that will be moved to the 2023 CIP will be Bickley Ct. A public meeting was held afterwards to discuss further.

6) Update Regarding the Jefferson St Bridge Project:

Scheel stated that the 2022 budget included borrowing for the replacement of the bridge however, that we are not in a position to move forward due state law that prohibits condemnation of land for bike and pedestrian facilities. The bridge is still in good repair and in good condition to safely use.

Motion by Reeves, seconded by Venegas to recommend that this project be removed from 2022 CIP Project and considered for the following year. Motion carried 6-0

Subject: Highway 51 Roundabout Landscaping Bid Outcome

Members of the Public Works Committee,

After reaching out to more than ten (10) landscaping companies to solicit a bid to perform the installation of landscaping on the three (3) new roundabout on Highway 51 and the rehab of the one (1) roundabout on Highway 138, we only received one (1) bid. Unfortunately, the one (1) bid that we did receive from Greener Valley Landscaping, was for \$285,000 to install the landscaping and \$12,000 for one year of additional landscape care and maintenance on all four (4) roundabouts. Our landscape designer's estimate for this project was \$103,000 for the installation of landscaping and \$19,500 for the one year of additional care.

I would suggest that the committee reject this bid as it is significantly over our allocated budget of \$117,000. We reached out to multiple prospective landscape companies to inquire why they didn't bid and we got many of the same replies. A vast majority of the landscapers simply said they do not have the capacity to do the work as their schedules are already full for the fall. Some said they were not willing to work within the tight window of time that we gave them to coincide with the DOT construction schedule. Others did not want to do work in the right of way. Going forward, I would suggest we consider the following to complete the project:

- Contract with another landscaper on just the existing roundabout on Hwy 138 to reestablish the landscaping this spring.
- Have the DOT put our specified seed mix in this fall in the specific areas outline in the landscape plan.
 Other areas
- Plant the ornamental trees that were specified in the plans this fall through our tree installation program.
- Rebid the balance of the project this summer to install the landscaping in the new roundabouts in the spring of 2023 with a completion date of June 1st 2023. They would be responsible for the maintenance of the landscaping through 2023. We can have a bid alternate for landscape maintenance in 2024.





Eligible Project Categories

The MPO will accept applications for most types of projects eligible for funding under the STBG-Urban program, as listed below:

- 1. Construction, reconstruction, rehabilitation, and operational improvements for roadways functionally classified as arterials or collectors, and bridges on roadways of all functional classifications, including improvements necessary to accommodate other modes of transportation and drainage systems for roadway runoff.
- 2. Capital costs for transit projects
- 3. Construction or enhancement of multi-use paths and/or grade separated bicycle/pedestrian crossings of major barriers.
- 4. Roadway and transit safety infrastructure improvements, including projects related to intersections that have disproportionately high crash rates and/or high levels of congestion.
- 5. Capital and operating costs for traffic monitoring, management, and control facilities and programs.
- 6. Infrastructure-based intelligent transportation systems (ITS) capital improvements.
- 7. Surface transportation planning programs.
- 8. Transportation demand management (TDM) programs, including rideshare/carpool programs and establishment and provision of transportation services by Transportation Management Associations.

Federally eligible projects for which the MPO will not utilize its STBG-Urban funds include reconstruction of existing multi-use paths or recreational trails unless the project includes a substantial enhancement (e.g., paving, widening), independent sidewalk projects (e.g., to comply with ADA), and most "transportation enhancement" activities, including environmental mitigation, historic preservation, and scenic beautification (see 23 U.S.C. Section 133 (b) for the complete list of eligible project activities under federal law).

Eligible Cost Categories:

The following are eligible costs for roadway projects under federal law and MPO policy:

- 1. Street/roadway construction*
- 2. Drainage systems needed to carry storm water runoff from street/roadway**
- Drainage systems nee
 Sidewalks***
- 4. Multi-use path, grade separated ped/bike crossing in corridor (where appropriate)
- 5. Transit facilities (e.g., bus priority treatment, bus pad, bus pull-out, bench or shelter, park-and-ride lot), including real estate cost for transit stops/stations.
- 6. Park-and-ride facilities in conjunction with roadway or transit projects, including real estate cost.
- 7. Standard streetscape items (lighting, colored crosswalks, etc.)
- 8. Signs and signals (where warrants are met)
- 9. Standard landscaping items (street trees, plants, etc.)
- * The needs of bicyclists and pedestrians must be considered for all roadway projects per federal and MPO policy. Projects must comply with the MPO's "complete streets" policy.
- ** Expansion of storm water system for future/planned development is not an eligible cost, but the local unit of government can fund the difference with 100% local funds.
- $\ensuremath{^{***}}$ Local units of government may only assess for the local match.

*Engineering costs are not included in the STBG or Local Share above
