#### 5. Memory Garden at Howard Heggestad Park

Dick and Diane Anderson would like to lead a project to add a memory garden walk to Heggestad Park (across Roby Rd. from Virgin Lake Park). A memory garden is a place where people go to reflect on someone that has passed. This garden would have paved paths with embedded engraved stones. The Anderson's would be responsible for the fund raising and planning of the park. Lynch felt that the park would benefit from the proposed improvements. The Parks and Recreation Committee liked the concept and believe it is a great addition to the City.

Lynch updated the committee on efforts to re-install components of the Born learning trail at Schefelker Park.


#### 7. Youth Center Update

<u>Note:</u> All prices listed are to be considered conceptual budgetary estimates. Total cost does not include any expense for permits, waivers, and / or licenses needed for this project and its phases (if required).

### • Phase #1: Decorative Paver Walkways (4' Width):

Delivery and installation of 740 sq. ft. Belgard 'Holland' paver walkways (Colors TBD) per design #2010-137.

Includes: machine excavation of existing gravel path and compaction of existing sub-base soil (compact to 95%), installation of: 850 sq. ft. geo-textile fabric, 25 cu. yrds. ¾" crushed aggregate w/ fines (compacted to 98% in 2" lifts for base), 3 cubic yards torpedo screed sand, 50 kits 'Snap Edge' paver edge restraint – w/ 600 - 10" spikes, 8 ½ pallets 'Holland' pavers, 19 - #55 lb bags polymeric joint stabilizing sand (color TBD), finishing grade around edges of walkway with 4 cubic yards pulverized topsoil (CN30), all repair to turf damaged during construction will be corrected by Moyer's Inc.

**Note:** This does not include cost for engraving pavers.

All equipment and fuel usage is considered for this phase. (MTL Skid Steer, Vibratory Plate Compactors, Transits, and specialty sawing equipment.)

Est. 135 Man Hours of Labor is considered for this phase. (ICPI Installation Standards and Engineering)

### • Phase #2: Decorative Paver Pavilion Patio (~30' x 20'):

Delivery and installation of 590 sq. ft. Belgard 'Holland' paver patio (Colors TBD) per design #2010-137.

Includes: complete removal and haul away of existing landscape debris, machine excavation and compaction of existing sub-base soil (compact to 95%), installation of: 675 sq. ft. geo-textile fabric, 20 cu. yrds. ¾" crushed aggregate w/ fines (compacted to 98% in 2" lifts for base), 3 cubic yards torpedo screed sand, 10 kits 'Snap Edge' paver edge restraint — w/ 120 - 10" spikes, 6 ½ pallets 'Holland' pavers, 15 - #55 lb bags polymeric joint stabilizing sand (color TBD), finishing grade around edges of walkway with 2 cubic yards pulverized topsoil (CN30), all repair to turf damaged during construction will be corrected by Moyer's Inc.

All equipment and fuel usage is considered for this phase. (MTL Skid Steer, Vibratory Plate Compactors, Transits, and specialty sawing equipment.)

Est. 101 Man Hours of Labor is considered for this phase. (ICPI Installation Standards and Engineering)

#### Phase #2 Total: \$ 10,943.73 (no sales tax on hardscaping)

#### Phase #3: Pavilion Patio Columns:

Delivery and installation of 4 Belgard 'Versa-Lok Standard' columns (Colors TBD) per design #2010-137.

Columns include: machine excavation and installation of 4 frost footings, compaction of sub-base soil (compacted to 95%), installation of: 75 sq. ft. geo-textile filter fabric, 2 cubic yards ¾" aggregate with fines (compacted to 98% in 2" lifts for base), 108 face feet 'Versa-Lok Standard' wall block (4 pallets), 40 'Universal Cap' units (1/2 pallet), and 36 - 29oz. tubes 'RG' concrete adhesive.

All equipment and fuel usage is considered for this phase. (MTL Skid Steer, Vibratory Plate Compactors, Transits, and specialty sawing equipment.)

Est. 32 Man Hours of Labor is considered for this phase. (ICPI Installation Standards and Engineering)

Phase #3 Total: \$ 4951.65 (no sales tax on hardscaping)

#### • Phase #4: Landscape Bed and Plant Installations:

Delivery and installation of landscape beds and plants per design #2010-137.

Includes all transplanting per design #2010-137 and installation of: machine bed edge using 520' (26 kits) 'Ace of Diamonds' contractor grade poly edging, 3 rolls 8' x 100' - 6 mil 'Visqueen' weed barrier, 21 cubic yards 'Double Shredded Hardwood Mulch', all plants per design #2010-137, and all soil amendments (peat moss, soil moist and root starter). Also includes  $1 \frac{1}{2}$  ton 1' - 2' field boulders for outcroppings.

Plant material planted by Moyer's Inc. includes a two year comprehensive guarantee

All equipment, delivery and fuel usage is considered for this phase.

Est. 42 Man Hours of Labor is considered for this phase. (Horticultural Installation Standards)

Phase #4 Total: \$ 6459.15 (+ Sales Tax)

#### • Phase #5 Budget: Pavilion:

Delivery and installation of 20' x 30' pavilion structure as per design 2010-137. All lumber and building materials included.

Note: Many options available for this phase; details yet to be determined.

Est. Labor is considered for this phase.

Phase #5 Budget: \$ 10,000.00 (+ Sales Tax)

### • Phase #6 Budget: Railings:

Delivery and installation of 200 linear feet of railing as per design #2010-137.

Note: Many options available for this phase; details yet to be determined.

Est. Labor is considered for this phase.

Phase #6 Budget: \$ 6500.00 (+ Sales Tax)

**Note:** All options and prices listed above are based on the materials and labor / equipment listed accordingly for each phase. Final material selections, size and layout and additional work requested will affect final price.

### **Terms of Payment:**

- 40% Down payment is due prior to scheduling and start of project
- Balance due upon completion of all phases accepted.
