Property will be transferred to City of Stoughton for management, with stipulation from Dane County that the City build a boundary/demarcation between public and private property, with the responsibility of the cost belonging to owner/developer.

6. Division Street Park Riverbank Restoration



7. Mid Town Trail and Riverfront Improvements




