Call to Order

1. Election of Chair. The Task Force nominated Jon who declined to accept. Bob was nominated next and approved.
2. Election of Vice Chair. Jon was nominated and approved.
3. Call to Order at 5:34 pm.
4. March 7, 2016 Minutes: Approved by Jon with a second by Joni. Carried.

There was discussion about the Mandt Park project along the river from Fourth Street to the bus barn as a potential project or a small boat launch before the dam. Old Business

4. River Clean-Up Review: It was described as “spectacular” with 25 bags of trash picked up. The Helen Johnson Trail sign was also unveiled, although she was unable to be in attendance. Photos were taken from the clean-up to be shared with the Hub.
5. Division Street Park Riverbank Restoration Update: The permit process is now taking place in the hands of the DNR. Sandra was requesting a handout that was provided last time by Aaron Steber. Nancy and Sandra will meet with Aaron to discuss plants.
6. Amundson Trail Update: The City Attorney has the easements with no approval yet. Jon sent a letter to him last week for an update on the approval. There are only three pieces of property that go directly to the river including the IKI property. The IKI property will be pursued first, with the rest to follow. Jim reported cutting of trees on the gravel trail and Tom was not aware of this cutting but will follow-up.
7. Kettle Park West Trails Update: Tom shared a current map of the area, explaining park land in that drawing.

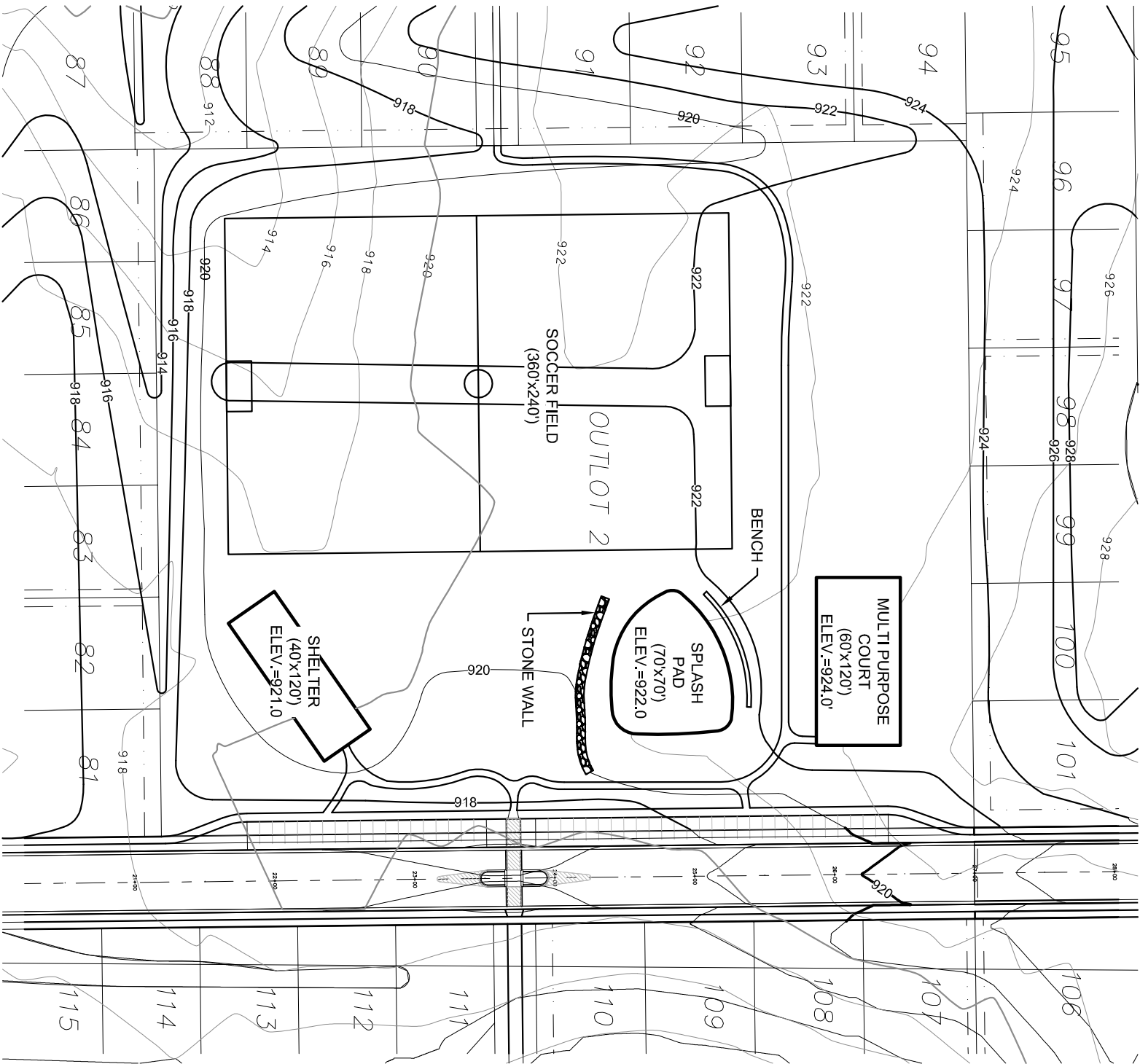












PARK PLAN
