## Activity Report Streets & Parks Department

September 15 – October 15, 2013



Feels like fall has arrived, mild days followed by cooler nights. It's a good time of the year.

Brush is the main task at hand for the crew. Crews started one week early due amount of brush placed out after thunderstorm and strong winds went through city in the middle of September.

Prior to the start of brush collection, crews were out with spray patch unit patching potholes throughout the city.

Yardwaste Site has started to pick up with grass starting to grow again with the recent rains and cooler temperatures. Residents are starting to drop off leaves, garden waste, and windfall apples. As of October 8th, there have been 821permits (sold 750 for entire year in 2012) sold to city residents this season and 160 permits issued to Dunkirk Township residents.

Tree crew had to deal with some downed trees and branches during recent thunderstorm. Contracted tree removal of 18 large parkrow trees will start Monday October 21<sup>st</sup> and be completed within a few weeks.

Tree stump removal has started; most of the stumps slated for removal have been removed and filled with dirt and grass seed.

Tree planting project will be starting soon. Contractors will be planting 80 trees in the parkrow where trees have been removed over the last few years.

Street crew replaced leaking water faucet in Riverside Cemetery.

Crews continue stormwater system maintenance with cleaning inlets, removing silt from greenways and repairing pipes.

The Fleet Maintenance Manager continues to keep the fleet in working condition for all city departments. Fleet Manager has fall leaf removal equipment ready for season, won't be long before winter equipment is equipped on trucks.

Parks Department summer activities have finished and have changed over to fall park activities. Mowing is still needed in all city properties and keeps crews busy. Contractor is having some issues getting East Park tennis court ready for overlay treatment. Other daily tasks include cleaning shelters and park cleanup.

Other routine tasks completed during the last month include; water tree along Jackson St & Kenilworth Court, hauling yard waste, dumping trash barrels downtown and cemeteries, cleaning fleet and garage, repair downtown street lights and traffic signals.

Once brush collection is completed, crews will focus on the following tasks; leaf collection, spray patching, street sweeping, installing signs @ stormwater ponds, cemetery cleanup, removing fishing piers, stump removal, and tree removal.



Call to Order: Engelberger called the Public Works Meeting to order at 6:00 PM

1) <u>Communications:</u> Manthe reported that there is a signed agreement for the E Main Street settlement in the amount of \$107,000.00. Crack seal contractors have already been contacted for bids and the work will be completed this fall with anticipated costs being no greater than \$5,000.00.

Mayor Olson ask Karl about an EAB seminar that the urban forester attended – Manthe stated that the discussion was about methods of treatment plans and stated that Evan Slocum – Urban Tree Alliance had completed the tree inventory and would be presenting the information to the Council at the September 24, 2013 meeting.

### 2) Activity Reports: (Manthe reported)

- Crews finished up street painting. Did additional curb painting downtown to assist Police Department with enforcing illegal parking issues long Main Street.
- Crews have gone back out to spray patch streets throughout the city. Street Department has switched over to an emulsion product that has longer shelf life.
- Yardwaste Site has slowed down a little bit with the drier weather. With fall just around the corner, expect yard waste volume to increase with garden waste and leaves being dropped off. As of September 9, there have been 803 permits sold to city residents this season and 155 permits issued to Dunkirk Township residents.
- Crews are out doing tree removals on hazardous trees throughout city. Have many trees on list to deal
  with and will stay active on tree removals for the remainder of the year. Have also scheduled the
  contracted removal of 18 parkrow trees that cannot be removed by city staff due to safety risks involved
  in the removal of these larger trees.
- Tree inventory completed, Urban Tree Alliance will provide presentation to Council on Management Report.
- Stump removal has started, currently have 18 stumps slated for removal.
- Tree planting project will be starting soon. Contractors will be planting 80 trees in the parkrow where trees have been removed over the last few years.
- Crews installed many new signs throughout city in addition to "No Parking Signs" along Racetrack Road.
- Crews continue stormwater system maintenance with cleaning inlets, removing silt from greenways and repairing pipes.
- The Fleet Maintenance Manager continues to keep the fleet in working condition for all city departments. Fleet Manager has started getting fall leaf removal equipment ready for season.
- Contracted boiler slag completed on various streets throughout the city. Part of preventive maintenance program to extend life of pavement.
- Parks Department summer activities have finished and have changed over to fall park activities. Crews
  are painting football and soccer fields for youth programs. Parks crew getting East Park tennis court
  ready for overlay treatment. Other daily tasks include cleaning shelters, park cleanup, projects, and
  mowing when needed.

- Other routine tasks completed during the last month include; water tree along Jackson St & Kenilworth Court, trimming weeds along roadsides, hauling yard waste, street sweepings, dumping trash barrels downtown and cemeteries, cleaning fleet and garage, repair downtown street lights and traffic signals.
- Busy time of year with construction projects coming to an end and switching over to fall and winter related tasks. Next up for crew is curbside brush and leaf collection.

### **New Business:**

- 3) <u>Approve August 20, 2013 Meeting Minutes:</u> Motion by Selsor seconded by Majewski to approve minutes. Motion carried 4-0 with the Mayor voting yes.
- Presentation from A T & T on Installing Cabinets in Right of Way: Manthe was contacted at the last minute from A T & T that no technical people were available to attend the meeting. Scheel stated that City has some concerns and issues. These cabinets are 6 X 4 and some would be placed in the right-of-way and depending on positioning could impact driving and snow plowing. Other concerns what will they look like, how many total are they expecting to place, length of time to complete the project, what is the long range plan. Engelberger ask staff for an opinion Scheel stated that the progress was probably inevitable but he will make sure the city is protected and encourage A T & T to seek private easements as they are considered a public utility. A T & T wanted to start work this fall so this issue will be placed on the October agenda.
- 5) Approve Street Department 5 Year Capital Improvement for Street Construction Projects: Manthe presented and discussed the Street Department 5 Year Capital Improvements for street construction projects and mentioned that Lincoln Avenue {Kriedeman to Roby} was not completed this year due to higher than anticipated bids and should be added to the list in 2014. Funds are being carried over for this project from the 2013 budget. Also noted was the Williams Drive {Page Cty B} project is in conjunction with Dunkirk Township and Pleasant Springs Township. All parties involved are applying for grants. The City of Stoughton will utilize TIF funding for project and have agreements with Townships. If approved, the City of Stoughton will qualify for Local Road Improvement Plan (LRIP) for additional funding opportunities.

Scheel stated that he attended a meeting with Stoughton Hospital and encouraged them to think about any changes they needed on Church/Ridge Sts when they are expanding the hospital to be done when the city is working on the streets in order to save duplicate work and costs.

Manthe discussed a project on Pine Street which had been moved back to the year 2016. A resident has inquired about this project to get completed sooner, but due to limited funding and traffic volumes on this street, it does not rate higher on the list of priorities.

Motion by Majewski, seconded by Selsor to recommend to Common Council to approve the Street Department 5 Year Capital Improvement Plan for street construction and to include Lincoln Avenue {Kriedeman to Roby} for the year 2014. Motion carried 4-0 with the Mayor voting yes.

6) Future Agenda Items: AT & T – cabinets

Moved by Majewski seconded by Selsor to adjourn meeting at 6:45 pm. Motion carried 3-0.

Representatives from AT&T will be present to answer any questions related to the placement of cabinets in right of way easements to improve the telecommunication services that are offered to Stoughton residents.



### Hi Rodney,

As we have discussed, there is a 170 foot long segment of sidewalk along the north side of Forton Street that is missing. The terrace in this segment is quite steep, which makes sidewalk installation difficult and explains why this sidewalk is "missing". In addition, no north-south ramps/crosswalks currently exist at the Forton Street/Manilla Street intersection. We have completed some preliminary design to determine the feasibility and costs for making the above improvements as discussed below.

### Ramps/Crosswalk at Forton Street/Manilla Street Intersection

Due to the location of existing storm sewer inlets on the west side of the intersection, it appears the most feasible location for curb ramps and crosswalk would be on the east side of the intersection. Construction of a curb ramp on the north side of Forton Street would require the back of sidewalk to be lowered by about 12-inches. This would require an existing boulder wall behind the sidewalk at this location to be reconstructed. The estimated cost for the curb ramps, sidewalk, and retaining wall is approximately \$5,000. A photo and exhibit showing the proposed crosswalk is attached for reference.

### Missing Sidewalk

The preliminary design for this segment of sidewalk is based on a 3 foot wide terrace and a 5 foot wide sidewalk. This results in the need for a retaining wall along the back of sidewalk (the retaining wall itself would be outside of the right-of-way). The retaining wall height will vary from about 1 foot to 6 feet in height. The estimated cost for this sidewalk and retaining wall construction is approximately \$35,000. A few photos and exhibits showing the proposed sidewalk area are attached for reference.

The curbs and apron area for the "alley" between Forton Street and Prospect Street would need to be reconstructed to construct curb cuts and ramps. The apron area has excessive cross slope. In order to correct this cross-slope, significant reconstruction of the alley would be required.

The driveway apron/sidewalk area for #104 Forton Street also has excessive cross slope (about 16%). Since the driveway area behind the sidewalk is gravel, it is possible to correct this (or at least drastically improve it).

The estimated cost for this work is based on a retaining wall unit price of \$35 per vertical square foot. This is based on using a modular block retaining wall system. Some of the existing retaining walls along Forton Street are boulder-type walls. If the city/property owners prefer the boulder wall-look, the cost for the wall would be about \$5 to \$10 less per vertical square foot (\$3,000 to \$5,000 less in total cost).

The improvements discussed above would be quite disruptive and costly to the abutting property owners. If the City elects to proceed with the above improvements, we recommend that a meeting(s) be held with the property owners to review the proposed improvements.
