### Street Trees Removal and Maintenance Policy

*Definitions*. For the purpose of this section the following terms, phrases, words and their derivations shall have the meaning given herein:

- (1) Public streets include all public streets, roads, alleys, sidewalks and easements
- (2) Public place include all public streets, parks and other lands owned or leased by the city.
- (3) Public trees and/or public shrubs include all woody vegetation presently or hereafter planted on any public areas.
- (4) Plant refers to any living organism which possesses a cell wall and is capable of synthesizing its own food from inorganic substances. It may or may not be woody.
- (5) Maintenance and protection shall include all operations of: trimming, pruning, spraying, injecting, fertilizing, treating, bracing, or cutting above or below the ground.
- (6) Hazard is any tree, or tree part with a potential to fail and with the presence of an adjacent target.
  - (7) Target includes people or property potentially affected by tree failure.
  - (8) Nuisance tree is any tree described as such in the standards and specifications.
- (9) Standards & Specifications refer to the Parkrow Tree Specifications addendum that describes those arboricultural standards and specifications which shall be followed relating to the planting, culture, and removal of any trees and shrubs. The addendum is not set out herein but is on file in the office of the Street Department.
- (10) Parkrow is the road right-of-way, typically the landscaped easement between the sidewalk and curb or street edge.

#### (m) Public tree care.

#### (1) Removal.

- a. The city may, on the recommendation of the Tree Commission to the Street Superintendent, remove or cause to be removed any tree or part thereof which is in an unsafe condition or which by reason of its nature is injurious to sewers, electric power, gas, or water rights-of-way, or other public improvements or is affected with any injurious disease or insect pest. Notification of such removal shall be given to adjacent land owners prior to such removal.
- b. No property owner and/or individual may remove or cause to be removed any tree on city-owned property without first obtaining written permission from the Street Superintendent. An application for the removal of a tree or trees shall be submitted to the Street Superintendent for review. The Street Superintendent shall consider among other things, the aesthetics of the area and shall weigh the harm to the city and the general area against the benefit of such removal to the property owner and/or individual when deciding on whether or not to grant the permission. The application for permission from the Street Superintendent will include: the reason for the removal and who will remove the tree. Any removal allowed under this section will be at the expense of the applicant. The city may require that a replacement tree be planted also at the applicant's expense if deemed necessary.

#### (2) Pruning.

a. All public deciduous trees in parkrows shall be pruned as needed by the City per the recommendation of the tree commission on a rotational basis of not more than ten years. This involves pruning each city-owned deciduous tree at least

once during this time period as needed based on the prune specifications described in the Standards and Specifications, which are not set out herein but are on file in the office of the street superintendent.

- b. Any public tree which because of growth habit, age, condition or disease becomes a hazard to public safety or obstructs a clear view of streets, signs, signals or intersections, will be maintained to correct the problem.
- c. Hanging limb and branch growth will be maintained 14 feet above streets and nine feet above sidewalks provided also that no part of the tree shall extend nearer than ten feet to the center of the street unless part of the tree is more than 20 feet over the surface of the street. Any trees not trimmed as herein provided shall be deemed hazardous. The city has the right to prune or remove any tree or shrub on private property when it interferes with the safe use of the street or sidewalk or when it interferes with the visibility of any traffic control device or sign at the owners' expense.
- d. There shall be no pruning of oaks (Quercus sp.) or elms (Ulmus Americana) between the periods of April 15 through November 1 to prevent the spread of disease. Any emergency trimming (from the period of April 15 through November 1) necessary to correct storm damage must have pruning wounds treated with a wound treatment compound or non-toxic thick paint at the time of limb removal. It is the responsibility of the person doing the pruning to treat those wounds.

#### (3) General care.

- a. Public trees shall be managed to promote their general health by providing the necessary cultural practices which may include insect and disease control, fertilization, irrigation, staking, wrapping, and pruning.
- b. Trees shall be maintained as not to endanger, interfere or otherwise conflict with requirements of safe public use of an area. Any tree which, because of an epidemic disease or insect infestation, poses a threat to other trees or plants in the community shall be treated to control the spread of the problem organism. The city will manage the public trees in such an instance and it is the responsibility of each homeowner to comply with this section as it relates to trees located on private property.
- (4) Protection of trees. All trees on any street or other city owned improved property adjacent to any excavation site or site of construction of any building, structure, or street work, shall be guarded with a substantial fence not less than four feet high and eight feet square with the protected tree sited in the center of said fence; or at a distance in feet from the tree equal to the diameter of the trunk in inches at breast height, which ever is greater. All building material, soil or other debris shall be kept outside the barrier. Caution should be used during the construction process to avoid damage to the roots, trunks, and branches of all street trees. Damage caused to any street tree, or irrigation system will be repaired at the discretion of the Street Superintendent and the costs of repair, rejuvenation, and/or value lost will be billed to the contractor or credited against the contract at the option of the city. Tree species which appear on the nuisance trees or other prohibited trees list within the standards and specifications of the tree commission, which are not set out herein but are on file in the office of the Street Superintendent, may be exempt from protection following consent of the tree commission.

Hi Donna,

Randy Nelson and I reviewed the list of trees to be planted and offer the following comments;

- The original plan with moving the Crabapple Arboretum was to preserve the legacy of Dr. Howard Heggestad by replacing all the species (approximately 71 different species with 2 planted for each).
- McKay is proposing planting 50 trees, when actually 69 trees need to be planted to have the total of 143 crabapple trees (malus Latin term)
- Latest design plan has a lot of discrepancies and overload of certain species (moved 2 Profusion from Arboretum, McKay has planted 2 more already and have plans to plant 4 more Profusion for total of 8 Profusion-should only have 2 total).
- List contains many non-crabapple species.

• Numerous other discrepancies exist with this entire project and the project has not gone smoothly to say the least.

Here is a breakdown of the remaining work and what has been billed to date. All prices include tax. Original contract was \$35,179.84. We are now looking at a price of \$32,679.91. Please verify your records.

### Work completed, Total of 73 trees- Cost of \$20705.66:

- Per Task 1, all has been completed except for the Key Plan. \$1750 Billed (\$250 Remains)
- Transplanting of Crabapple Trees- 23 Small, 32 Large crabapple trees
- Watering and Mulching of initial trees \$1875.00
- 17 Crabapples Planted \$1,275.00

Work to be completed, planting of 50 Trees for a total of \$11,974.25. In addition we will provide a final plan and key/ brochure/map for the site.



- Alder Swangstu announced that there will be a fish boil at the American Legion this Saturday, September 28.
- Alder Hohol announced that the Stoughton Dream Park Organization is having a Dream Fest Event on Saturday, September 28.
- Evan Slocum of the Urban Tree Alliance gave a presentation on the 2013 Stoughton Tree Inventory and Urban Forest Management Plan. The Urban Tree Alliance have inventoried the trees in the City and will be updating the existing inventory and management plan. They found the most dominant species was the Norway Maple. The Emerald Ash Borer has not been discovered in Stoughton yet. The full report can be found on the City website and in the Council packet. Mr. Slocum also mentioned that the Streets Department doesn't have enough dedicated staff to take care of the trees. Mayor Olson commended and thanked the tree specialists along with Karl Manthe and his staff.
- Scheel reported that City staff is preparing to have the general development plan for Kettle Park West reviewed by the Planning Commission.

Nelson will be discussing the program, the partnerships, the progress including a bill that needs to be paid for boards that were done for the city.

Tree Commission Meeting Minutes Wednesday, August 14, 2013 at 6:30 PM Hall of Fame Room at City Hall, 381 E Main, Stoughton, WI

<u>Members Present:</u> Tom Selsor, John Archer, Jay Schotzko, Bonnie Kennedy, Dave Moyer, Rick Gullickson, Sean Grady and Randy Nelson

Absent & Excused: Kevin Short

Guest: David Kneebone

Call to order: Meeting called to order at 6:30 PM by Schotzko

- 1) <u>Communications:</u> 1) Nelson and Gullickson met with Evan Slocum to discuss the tree inventory and give information for Evan to write a management plan. Nelson stated the inventory should be completed by early September. Evan will meet with the Tree Commission in September. 2) Nelson informed the committee that a bench had been made and placed in Norse Park by Mayor Johnsons' tree that was recently planted there. This bench was made by "Avery Royer" with recycled wood from the city,
- 2) EAB Plan Treatment and Permit: The permit was reviewed and multiple changes were made including adding a disclaimer, comment section and stating incomplete applications will not be processed. The arborist will review the form and his report will be attached. A suggestion was made to charge a minimal fee for the permit and use the money to purchase more trees. Nelson stated that he had asked for \$5,000 to be budgeted for treating city ash trees. The City of Edgerton has offered to cost share (City would be responsible for their own chemicals) with them as they have already purchased the injection equipment. Motion by Schotzko, seconded by Moyer to make the necessary corrections to the permit and recommend to the Public Works Committee to require a resident to fill out the permit if they choose to treat a public tree on their property. Motion carried 5-0.
- 3) ATC Grant Application: Nelson is currently working on the application and talked with Adam on several areas that would qualify. Cummins has agreed to participate in the planting / caring of the trees. They also suggested using fruit trees that could be harvested and donated to the food pantry. Two locations were reviewed the corner of Page & Williams Drive and an area in Bjoin Park. Nelson is working with nurseries to supply the trees. This application must be submitted by September 1<sup>st</sup>.
- 4) Street Department Budgeting & Staffing Needs Letter to Mayor Olson: The committee reviewed the letter and a few minor changes will be made. Gullickson stated that the Mayor had indicated that additional personnel have been taken out of the process due to an extremely tight budget. The city's urban forest has hazard trees that need attention and if EAB arrives there will be an additional work load. After much discussion regarding the conditions of the trees the committee felt that is was still important to speak up and discuss what is needed. Motion by Schotzko, seconded by Moyer to send the letter and back up materials to the Public Works Committee for review. Motion carried 5-0.
- 5) <u>Approval of minutes from July 10, 2013 meeting:</u> Motion by Kennedy, seconded by Archer to approve the minutes. Carried 5-0.
- 6) <u>Heggestad Crabapple Arboretum:</u> The committee was not happy with the response from Nelson Global. *Schotzko* met with Mayor Olson on Monday, August 12 to discuss the situation. Mayor Olson is going to meet again with Nelson Global to discuss receiving the plan/brochure/map and other

discrepancies. *Moyer* stated that there are at least 2700 varieties of crab trees and McKay Nursery should be able to find crab trees and not plant other species as suggested – this is a crabapple arboretum which was funded by the Heggestad family. The committee has agreed to give the Mayor some time to resolve the issue before proceeding in a different direction.

- 7) Ord 64-14(f): Schotzko wanted to discuss the wording on this ordinance to verify that the homeowner wasn't going to be restricted by the changes that were made. After discussion the committee felt the wording was ok.
- 8) Raffle Review, Suggestions and Discussion: --- Tabled until October.
