1. Call to Order

Meeting called to order by Hirsch at 6:00 PM

2. Approval of the Minutes from October 17, 2017

Motion by Reeves, seconded by Bartlett, to approve the minutes of October 17, 2017 as presented. Motion carried 4-0.

3. Communications

Nordic Ridge Solar Panel

Lynch sent out 5 proposals for the construction of a solar panel on the shelter roof at Nordic Ridge. He has been working closely with Cory Neely of WPPI on preparing a grant in early January.

Mandt Park Project

Dan Glynn updated the committee with a positive conversation with DNR personnel and an upcoming meeting with an economic impact expert. Both of these push the Whitewater Park forward.

Virgin Lake Trail

Street and Parks staff, Rec staff and members from Cummins will be meeting so to go over options for creating public access in the Virgin Lake area with boardwalks and mowed trails.

Mandt Community Center Contract

Mayor Olson informed the committee that the loan for the MCC will be paid off in February.

Old Business

4. Fair Contract

The committee made adjustments to the Fair contract proposal. Lynch will move the contract to the fair board for initial review.

5. Easement with Stoughton Hospital Hospital

The committee reviewed the Right of Way Easement for Public Recreation Trail that was prepared by our attorneys and Stoughton Hospital. This easement will provide access for a walk/bike trail that will extend from Amundson Park to Stoughton Hospital along the river.

Motion by Bartlett seconded by Reeves to recommend to Council to approve the Right of Easement for Public Recreation Trail with Stoughton Hospital to provide access for a walk/bike trail. Motion passed 4-0.

New Business

6. Disc Golf Course Wayfinding Signs

Sharon Mason Boersma of the Kiwanis Club is working with John Halverson of the Street Department on the purchase and installation of way finding signs near Amundson Parkway to highlight the Kiwanis Disc Golf Course in Amundson Park.

7. Parks and Recreation Director Position

Amy Jo Gillingham presented a recommendation to keep the Parks and Recreation Department staff as is and move the current Recreation Supervisor into the Parks and Recreation Director

position. Hirsch supported the plan but wanted the new Recreation Supervisor position to be looked at to improve the overall skill set for the department.

Motion by Bartlett seconded by Reeves to recommend to the Personnel Committee to maintain the current structure of the Parks and Recreation Department and promote from within. Motion passed 4-0.
