Planning Commission Meeting Minutes

Monday, December 10, 2012 - 6:00 p.m.

1. Call to order. Mayor Olson called the meeting to order at 6:10 pm.

2. Consider approval of the Planning Commission meeting minutes of November 12, 2012.

Motion by <u>Christianson</u> to approve the Planning Commission minutes of November 12, 2012 as presented, 2^{nd} by <u>Hohol</u>. Motion carried 4 - 0.

3. Council Representative Report.

Hohol stated on November 27, 2012 the Common Council had a first reading of the ordinance amendment related to outdoor displays with a second reading coming on December 11, 2012.

4. Status of Developments/Projects.

Scheel introduced the status of developments. There were no questions.

5. The Bryant Foundation requests to rezone 305 S. Page Street from MR-10 - Multi-Family Residential to CB - Central Business.

Scheel gave an overview of the rezoning request.

Mayor Olson opened the public hearing.

Alice Forsythe spoke with concern about how parking would affect the neighborhood.

Jerry Gryttenholm stated there will be minimal impacts related to parking. A brief discussion took place with the Commissioner's related to tax exempt status of proposed use as a Norwegian Heritage Center. Jerry Gryttenholm stated the intention is to pay taxes.

Karen Marsh, who owns the property next door, spoke with concern about their sewer line and the access easement to Page Street.

Jerry Gryttenholm stated they will respect the easement. Mayor Olson closed the public hearing.

Hohol stated the site plan will be coming back to the Planning Commission in the future and at that time the parking can be reviewed.

Motion by **Hohol** to recommend Council approve the rezoning ordinance as presented, 2^{nd} by **Odland.** Motion carried 4 - 0.

6. The Bryant Foundation requests to combine the properties at 277 W. Main Street and 305 S. Page Street by Certified Survey Map. Scheel explained the request.

Motion by <u>Hohol</u> to recommend Council approve the Certified Survey Map contingent on the rezoning, 2^{nd} by <u>Christianson</u>. Motion carried 4 - 0.

7. Chris Overson requests a Conditional Use Permit (CUP) to allow indoor commercial entertainment (Pool Hall) and an upper story dwelling unit at 556 E. Main Street.

Scheel gave an overview of the request.

Mayor Olson opened the public hearing.

Chris Overson made himself available for questions. A discussion took place regarding the uses. Overson stated the plan is to have a pool hall, offices for his business and possibly assembly. Overson plans to apply for a beer and wine license but has no plan to have the primary use be a tavern. Overson stated the business would close by midnight.

Mayor Olson closed the public hearing.

Hohol questioned if the conditional use permit covers alcohol consumption. Scheel stated alcohol consumption would be allowable with a proper liquor license and the upper story dwelling is also covered under the conditional use. Hohol questioned if there would be a designated area for smokers. Overson stated he would likely have a spot along the building but is concerned about littler.

Motion by <u>Christianson</u> to recommend Council approve the Conditional Use Permit Resolution to allow indoor commercial entertainment (pool hall – tavern) and an upper story dwelling unit at 556 E. Main Street contingent on the staff review letter dated December 3, 2012, 2^{nd} by <u>Hohol.</u> Motion carried 4 – 0.

8. Resolution to oppose Dane County Ordinance Amendment 33, 12-13. Mayor Olson gave an overview of the request.

Motion by <u>Hohol</u> to recommend Council approve the resolution as presented, 2^{nd} by <u>Christianson.</u> Motion carried 4 - 0.

9. Discuss single family and duplex construction starts community comparison.

A brief discussion took place regarding average construction values and the affect a 4-lane highway could have. There was agreement that Stoughton needs larger lots to accommodate higher end homes.
