8. Page Street Mart New Liquor Application

Motion by Payton, second by Ligocki to recommend to Council the application for Neighborhood Liquor (formerly the Food Pantry). Motion carried 5-0.

10. Sean Anderson Liquor License non-approval

The applicant was not present as required for discussion of the application. Chair Jenson recommended the application be tabled until next month to allow legal counsel to attend. Motion by Payton, second by Ligocki. Motion carried 5-0.

11. Coopers Causeway Parking

Brief discussion, Ligocki explained the request to be an agenda item, pedestrian safety being a big concern. Suess Charleston noted she uses it and does not feel there is a safety issue.

12. a. Wilson Street parking

Chief Jenks reviewed the photo requesting no parking at the intersection. (#91)

12. Maple Court Parking

Discussion followed with the recommendation to paint yellow for no parking 70 feet at the intersection. (#92)

Motion by Ligocki, second by Suess Charleston recommends approval of prohibited parking at all times for item #91 but does not recommend approval of item #92. Item #92 should be removed from the amendment to the ordinance Sec. 70-176. Motion carried 5-0.0
