NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Stoughton as follows:

- 1. That the report of the City Engineer pertaining to the construction of the above-described improvements, including plans and specifications therefore is hereby adopted and approved and it is hereby directed that such work be carried out in accordance with the report of the City Engineer.
- 2. That payment for said improvements be made by assessing the cost to the property benefited as indicated in said report.
- 3. That benefits and damages shown on the report are true and correct and are hereby confirmed.

- 4. The assessment levied against any parcel shall be paid in cash on or before November 1, 2011, or if over \$200.00, plus interest at 4.5%, by five (5) annual installments; or if over \$1,500.00, plus interest at 4.5%, by ten (10) annual installments; or may be deferred only on such terms and in such manner as prescribed by the Stoughton City Council, as referred to in Section 2-646 through 2-654 of the Stoughton Municipal Code while no use of the improvements are made in connection with the property pursuant to Section 66.0715(2), Wisconsin Statutes.
- 5. The City Clerk is directed to publish this resolution as a Class I notice in the <u>Courier Hub</u>.
- 6. The Clerk is further directed to take such action as to cause a copy of this resolution and a statement of the final assessment against stated properties be mailed to every property owner whose name appears on the assessment roll whose post-office address is known or can with reasonable diligence be ascertained.
