#### **Mandt Park Waterfront Development Update**

Dan Glynn, Parks & Recreation Director



Recreation Engineering and Planning is acting as the master planner for the project. The design elements include:

- Whitewater park design
- Bank restoration with ease of access considerations (access for people with disabilities)
- Fishing improvements and access
- Trails along both sides of the river
- Pedestrian bridge connecting Mandt Park to the RDA site

Vierbicher is providing cost estimates for a trail along the river by the utilities building and Uniroyal that would connect to Water St. They are also providing cost estimates for a rental facility and parking lots in Mandt Park.

The DNR's Stewardship Fund could cover up to half the cost of everything excluding non-public space at the rental facility. Permits are not needed to apply, but we would need the easement from Uniroyal.

I had a conversation with Chris Valcheff of True North Consultants about the possibility of contaminated sediment. Chris has been working with the RDA and knows the area. He said that it would be roughly \$2,000 to sample the streambed and if contamination was found it would cost between \$50 to \$1000 per ton to remove contaminated and dispose of it. There are federal grants that would pay for the cleanup.

The next step is to create a steering committee for the project that will help guide the project forward. The project is a good candidate for a steering committee because of cost, timeline, and the RDA site.
