# **Community Development Authority update:**

Sullivan and Becker outlined the steps to establish a Community Development Authority (CDA). First step is for the RDA to decide if they are in support of the change, then the Housing Authority and Council will need to give approval. Matt Dregne, the city attorney, will then need to go thru the legal aspects and then the city auditors will need to go thru the financials. The complete process will take around 6 months to accomplish. The RDA responsibilities would remain basically the same, but would serve more as a sub-committee under the CDA. This would be an organizational change more than anything. Moved by Christianson, seconded by Selsor, to acknowledge support of the formation of a Community Development Authority. Motion carried unanimously.

# **Revolving Loan Fund Update:**

Sullivan reported there is one loan in progress and was heading to the WBIC loan committee within a week. Loan was for equipment for the Viking Brew Pub. This will be our first successful loan for the Revolving Loan Fund.
