Call to order: Dale Reeves called to the meeting to order at 6:00 p.m.

Communications:

Hirsch stated she received an email from Director Glynn regarding the DNR grant to fund the pedestrian bridge and unfortunately, they are pulling that money for this year. They are only funding the trail and trail amenities due to possible removal of the dam.

Old Business

- a. Discussion on results of August 7, 2019 Brink presentation
Reeves said attendance was beyond expectations. Overall was an interesting and well attended meeting.
- b. Update from Downtown Revitalization subcommittee
Discussion by Duranczyk. Market survey went out last Monday, August 2nd. 319 returned surveys after 1 week. Will be out handing out survey post cards. Hoping for 1,000 surveys returned. October 1st, will be first public meeting and will be held at Lagaret from 5-8 p.m.
- c. Grant updates and upcoming Brownfield grant opportunity

Gary Becker handed out a Brownfield summary of grants that are available. Explaining what would happen once the grants were given. Grant would be up to \$500,000.00 Site grant is in process of being approved. WEDC has been communicating that they are wrapping up their part and will have a reward letter any day now.

- d. Power Plant boundary and Public works demolition updates
Hirsch discussed what was talked about at council last night regarding boundary lines. Questions on the southern property boundary. Demolition within next week should have demo specs for public works building, looking to get it approved. Then send out to bid.
