Carl Sampson Park – motion by Schumacher, second by Ligocki to name the park Carl Sampson Park. Ligocki asked for an amendment that the park be named Carl Sampson Park, in honor of all Seniors. Mayor Swadley stated Ligocki could work with Public Works, an amendment was not needed.

Tikalsky asked that in the future the entire topic should be considered of naming things after people. Mayor Swadley noted CACP is where that discussion would begin. Motion carried 11-0 to approve the name Carl Sampson Park for the area next to the Senior Center along the riverbank.
