Mayor Swadley announced that Kirsten Ott at the Senior Center successfully performed the Heimlich maneuver and saved a life.

Mayor Swadley thanked the member of the Fire, EMS and Police departments for the assistance they provided to Sun Prairie after the explosion.

Peggy Veregin provided Stoughton Landmarks Grant Program Update.

R-136-2018- Lifting of the Council-Imposed Demolition Moratorium for 305-315 E. Main Street

Motion by Boersma, second by Duranczyk to approve R-136-2018 Lifting of the councilimposed demolition moratorium for 305-315. Boersma provided a history of the building and the application for demolition. Hirsch said that the Planning Commission should look at allowing a private park on the parcel. Duranczyk said that that the parcel could provide a space for sculpture or art to develop a brand for the City and the Riverfront development. Johnson said that the City should not move forward with lifting a moratorium until the ordinance amendments are complete. She added that the building should have never been able to get as deteriorated as it is now.

The council waived the rules to allow the Kittelson family to address the council. Mr. and Mrs. Kittelson said that the building had been in disarray for 7-10 years before the bought the building. They added that they have been working to do something for 19 months with the property and have had roadblocks at every step.
