Budget is due to be approved November 12th at the City Council meeting. We were very happy that the Council made a commitment to the Programming/Volunteer Coordinators position moving forward. Some funding still comes from the Bryant Foundation, but now the City pays for some of the costs as well.

Evaluation of Senior Center is available now. Should see it emailed soon if you would like to complete it on line. We still plan to send it directly to some area of the City to try to reach some folks that may not currently participate at the Center.

Legislative Update:

Cindy reported that the County Executive has included in his budget a small increase in Case Management funding and as introduced an initiative regarding Mental Health services to help our Case Managers, similar to the Mobile Outreach to Seniors Team that once existed in Dane County. This will be very welcomed by our case managers who struggle often with clients who have difficulties with mental illness.

Cindy was asked to give an update regarding the Seniors in Need Fund. In 1995 the Senior Center worked with city volunteers and Mayor Helen Johnson to create a fund to help unmet and crisis needs for community members 55 years of age and older in the Stoughton Area School district. Referrals to the committee come from case managers, a budget screen is done and an assessment of other programs that may be appropriate. All funds are donated; no city funding is used. Hundreds of individuals have been helped. Referrals remain anonymous to committee members.

Cindy suggested that the Commission not meet in December due to lack of agenda items and busy person schedules. D. Sharpe made a motion to not meet in December, B. Barnett seconded, passed unanimously.
