<u>June Minutes</u>: Moved by R. Jensen, seconded by S. Boersma to approve; passed unanimously.

Director Comments: Cindy McGlynn

- Staff is beginning planning for the Fall. September is Senior Center Month.
- Cindy is beginning the 2016 budget.
- All sales of Chose's Coney Dogs served at this week's Rotary Park Gazebo Concert Series will go to Seniors In Need. Also for a *limited* time, Chose's Coney Dog Sauce will be for sale at the Senior Center for \$5/lb.
- More education is needed to help distinguish the difference between Seniors in Need (SIN) and the Senior Center. Some contributors think they are one and the same and will write checks to the Center, but with a memo for it to be used towards Seniors in Need.
 Seniors In Need:
 Is a committee appointed by the mayor that serves to address the unmet needs of older residents of the Stoughton Area School District (City of Stoughton, Towns of Albion, Dunkirk, Dunn, Pleasant Springs, and Rutland) with privately donated funds.
 Referrals are made by case managers from Stoughton or McFarland Senior Centers after all federal, state, county and local social services/resources have been exhausted, and a plan has been developed to remedy future foreseeable needs.
 So while, Senior Center staff provide some of the screening and referrals for Seniors in
 - Need, the Committee and Fund is a separate entity from the Senior Center.
- A suggestion was made provide an article to the Hub and newsletter clarifying the missions of Seniors in Need and other community social services.
- Question was raised about the old troll stored in the parking garage; it will be disposed.
- Requests COA's assistance at August's meeting to update the Bylaws.

Strategic Plan

- It was discussed and decided that we have a good basis for self-assessment through the work we've done maintaining our national accreditation standards. For that reason, Cindy proposes and COA agrees to the following ideas for this year's Strategic Plan process:
 - Spend most time on gathering information from the community (Center participants, non-participants seniors, schools, businesses, city, towns, etc.) through focus groups.
 - Come up with key questions tied to critical issues concerning the aging population and the Senior Center's role for the focus groups to discuss.
 - Hire or use existing staff or COA members to facilitate focus groups –TBD.
 - Make the focus groups appealing to participants –a one-time meeting, no more than 2 hours with a free meal.
 - o Revisit the planning process again in 2-3 years, instead of 5 years.
 - o Tentative timeline is to complete the plan by the end of the year.
- At August's meeting, staff will have suggestions for how the COA to decide how to proceed.
