

**Finance Committee of the City of Stoughton  
Tuesday, August 9, 2022 @ 6:00 p.m.**

The meeting was a hybrid meeting located in the City Council chambers of the Public Safety Building at 321 S. Fourth St as well as concurrently held via Zoom.

**Committee members present:** Brett Schumacher (Chair), Greg Jenson (Vice Chair), Leonard "Ozzie" Doom, Ben Heili (remote), and Lisa Reeves

**Members absent:** Tim Swadley (Mayor, ex-officio)

**Guests present:** Dave Ehlinger and Rodney Scheel (remote)

1. **Call to order** – The meeting was called to order at 6:01 p.m. by Schumacher.
2. **Establish a quorum** – A quorum of committee members was present.
3. **Communications – Net New Construction and Equalized Values** – Ehlinger recapped the memo. General discussion occurred on the topic.
4. **Reports** – None at this time.
5. **Approval of July 26, 2022 Finance Committee minutes** – Motion by Reeves/Jenson to approve the minutes as drafted. The motion passed 6-0.
6. **R-158-2022 – Authorizing and directing the proper City official(s) to enter into an Access Agreement with Uniroyal Global Engineered Products ("Uniroyal")** – Scheel gave an overview of the resolution and historical context. Motion by Doom/Reeves to recommend approval to the Common Council. The motion passed 6-0.
7. **R-xxx-2022 – Amend 2022 adopted budget for American Rescue Plan Act (ARPA) Fund** – Ehlinger gave a recap of the proposed resolution. Motion by Heili/Jenson to recommend approval to the Common Council. The motion passed 6-0.
8. **R-xxx-2022 – Amend 2022 adopted budget for Arts Council Fund** – Ehlinger gave a recap of the proposed resolution. Motion by Jenson/Doom to recommend approval to the Common Council. The motion passed 6-0.
9. **R-xxx-2022 – Amend 2022 adopted budget for Fire Pension Fund and Fire Equipment Fund** – Ehlinger gave a recap of the proposed resolution and indicated Joshua Ripp is okay with the proposed changes. Motion by Jenson/Doom to recommend approval to the Common Council. The motion passed 6-0.
10. **R-xxx-2022 – Amend 2022 adopted budget for Safety Building Fund** – Ehlinger gave a recap of the proposed resolution. Motion by Jenson/Heili to recommend approval to the Common Council. The motion passed 6-0.
11. **R-xxx-2022 – Amend 2022 adopted budget for Technology Fund and IT-Media Services --** Ehlinger gave a recap of the proposed resolution and that John Montgomery supported the resolution. Motion by Jenson/Reeves to recommend approval to the Common Council. The motion passed 6-0.
12. **R-xxx-2022 – Amend 2022 adopted budget for Tourism Fund** – Ehlinger gave a recap of the proposed resolution. General discussion occurred regarding access to data from the prior accounting system. *[Update: Information Technology has confirmed the prior accounting was on a server that malfunctioned. Data from prior to BS&A Software is no longer available.]* Motion by Jenson/Doom to recommend approval to the Common Council. The motion passed 6-0.
13. **R-xxx-2022 – Amend 2022 adopted budget for vested compensated absences** – Ehlinger recapped the proposed resolution. General discussion on the topic occurred. Motion by

Zoom/Jenson to recommend approval to the Common Council. The motion passed 6-0.

14. **R-xxx-2022 – Amend 2022 adopted budget for Sick Leave Fund** – It was noted this proposed resolution was not in the packet. Ehlinger was directed to include this item on the 08/23/2022 agenda as a time sensitive item for Common Council consideration that same evening.
