Guiding Articles for the Stoughton Hall of Fame

Article 1. Name

The name of the organization shall be "The Stoughton Hall of Fame".

Article 2. Object

The purpose of the Stoughton Hall of Fame shall be to preserve the accomplishments of certain individuals and to present to all prosperity the lives of persons who have made a lasting impact upon our society in this community, state and nation. (*People from Stoughton that "made good".*)

Article 3. Committee Members

The committee members shall control this organization. They shall be appointed by the Mayor and confirmed by the Common Council annually.

Article 4. Duties of Committee Members

Committee Member Responsibilities

Section 1: It shall be the duty of the committee members to select the inductees for the Hall of Fame and inductees shall be chosen by a simple majority vote.

Section 2: It shall be the duty of the committee members to present in an orderly fashion and display for all to see the accomplishments of the candidates for the Hall of Fame.

Article 5. Candidates for the Hall of Fame

Eligibility of Individual, Couples or Groups of Candidates

Section 1: Candidates must have been born in the Stoughton area or have lived in the vicinity (15 miles) for a period of five years.

Section 2: Youth who have attended the Stoughton High School are eligible.

Section 3: Both the dead and living are eligible.

Section 4: Candidates can come from all walks of life.

Section 5: Care is to be taken in the selection of candidates that it be for excellence in their respective fields and not as an award for a timely success.

Article 6. Amendments

These articles may be amended or repealed or added by majority vote at the annual meeting.
